TERMS & CONDITIONS FOR EXHIBIT SPACE

GOA AUTO SHOW 2025

Organised by **India Intercon / Indus News & Media Pvt. Ltd.**

1. DEFINITIONS

- **“Exhibitor” / “Participant”**: Includes the applicant company and its staff, agents, or representatives.
- **“Exhibition”**: Refers to the Goa Auto Show 2025.
- **“Organiser”**: Refers to India Intercon / Indus News & Media Pvt. Ltd., Mumbai.

2. APPLICATION FOR PARTICIPATION

- All applications must be made on the official space application form.
- Booking is confirmed only after submission of the signed form and payment of **50% participation fee**.
- By signing, the Exhibitor agrees to all terms unconditionally.

3. SPACE ALLOCATION

- Space will be allocated based on exhibit type and layout feasibility.
- Organisers reserve the right to modify allotted space at any time before setup. No compensation is applicable for such changes.

4. USE OF EXHIBIT SPACE

- Exhibitors must display only the products/services listed in the form.
- All booths must be manned during show hours.
- Subletting or sharing booth space is not permitted without written permission.
- Damage to venue structure or property will be charged to the Exhibitor.
- Obtaining required travel documents or permissions is the Exhibitor's sole responsibility.



5. PAYMENT TERMS

- **50% deposit** upon signing.
- **Remaining 50% due 30 days before the event.**
- Late or incomplete payments may result in forfeiture of space and deposit.

6. CANCELLATION & WITHDRAWAL

- Withdrawal or cancellation by the Exhibitor after confirmation will result in forfeiture of the deposit.
- Partial cancellation may lead to space reallocation and partial billing, subject to Organiser's discretion.

7. EVENT POSTPONEMENT OR CANCELLATION

a) In the event of force majeure (natural disasters, lockdowns, etc.), the Organiser reserves the right to:

- Postpone, relocate, or cancel the exhibition.
- In such case, the Exhibitor may cancel within 7 days of notification and will be eligible for a refund or credit note.
- Such changes do not constitute breach of contract by the Organiser.

8. STAND CONSTRUCTION & DECORATION

All construction and decoration must be completed by the schedule communicated in the exhibitor manual. Any changes must follow the venue's fire and safety regulations.

9. MOVE-IN / MOVE-OUT

All material must be removed by the assigned dismantling period. Delays or damage will be billed to the Exhibitor.



10. SECURITY

While reasonable precautions will be taken, the Organiser is **not liable for theft, loss, or damage** of exhibitor property during move-in, show days, or dismantling.

11. INSURANCE

All Exhibitors are advised to carry appropriate insurance for their displays, equipment, and liability. The Organiser will not be responsible for any losses.

12. FIRE SAFETY

All materials used must be fire-retardant as per venue regulations. The Organiser reserves the right to inspect and enforce compliance.

13. SUPPLEMENTARY REGULATIONS

- The Organiser may issue additional guidelines or manuals to ensure smooth execution of the show.
